- _____ 1. Two (2) blueprints or ink drawings of sign plans including:
 - Sign Message, color(s), and graphics to be used.
 - Specifications of sign.
 - Method of construction and attachment to building or ground.

- _____ 2. Written consent of property owner.

- _____ 3. For electrical signs show location of disconnect switch per current National Electrical Codes. All electric service shall be underground for pole and ground signs.

- _____ 4. On a separate Site Plan note the location of all existing signs on the premises including:
 - Message of sign(s)
 - Dimension of sign(s) and placement on site or building.

- _____ 5. A Site Plan must be provided showing the precise location of the ground sign with respect to the public road right-of-way line. All such signs **MUST BE AT LEAST (10') FEET BACK OF THE RIGHT-OF-WAY LINE** (measured from the edge of sign).
- _____ 6. Provide one (1) copy of stress calculations prepared by a Missouri registered structural engineer for pole or directory signs.
- _____ 7. For all wall signs provide scaled, elevations, drawings or photos indicating the wall for the proposed sign indicating the length and height of the building (or lease unit), and sign dimensions. If wall sign is based on building façade, applicant must provide building profile documenting the appropriate dimensions.

SIGN INSPECTIONS – FOOTING AND ELECTRICAL

- All electrical connections must be installed by a St. Charles County licensed electrical contractor.
 - Footing inspection must be requested twenty-four (24) hours prior to pouring concrete, for ground and pole signs.
 - Contact the Wentzville Building Division at 636-327-5102 to schedule inspection twenty-four (24) hours in advance.
 - Permit holder will need the permit number in order to schedule the inspection.
 - *Pole signs which exceed ten (10') feet in height require engineered design and calculations.
